



2018 WORK PERMIT TO ENTER AND REMAIN ON ABORIGINAL LAND

ABORIGINAL LAND ACT 1980, Northern Territory of Australia

The person whose name is set out below is authorised to enter onto areas of Aboriginal Freehold Land as listed below, and remain there for the purposes of work. This permit is NOT required for accessing and working in the communities of Angurugu, Milyakbura and Umbakumba.

Please note that a separate Recreation Permit is required to visit recreational areas.

In accordance with Sections 4 and 5 of the *Aboriginal Land Act*, the person named above herein applies in writing for a Work Permit to the Anindilyakwa Land Council (the 'ALC'). The ALC acts on behalf of the traditional land owners of the above mentioned townships.

By signing this permit you are authorising the Northern Territory Police to carry out a police check and release such details to the ALC.

CONDITIONS OF PERMIT

- Aboriginal Land - means Aboriginal Land as defined in the Aboriginal Land Rights (Northern Territory) Act 1976 (ALRA) and includes the roads bordered by the Aboriginal Land and includes any Aboriginal Land traversed by the Permit Holder to gain access to the Consented Areas.
- Consent Areas - mean the areas delineated in the above table.
- The ALC, with consent from the Traditional Owners, have granted permission for persons listed above to visit the Consent Areas for the express purposes of work related activities.
- This permit must be carried at all times by the Permit Holder whilst on Aboriginal Land and produced for inspection on demand by a member of the NT Police Force and any persons delegated the authority by the Anindilyakwa Land Council.
- This permit is issued on the basis that persons to whom it is issued enter Aboriginal Land at their own risk and agree that none of the Anindilyakwa Land Council, its members and employees, traditional Aboriginal owners, the Anindilyakwa Land Trust, or the occupiers of the Aboriginal Land entered by the Permit Holders are liable either jointly or severally for any loss, damage or liability of any kind whatsoever however arising out of or in relation to the entry of the permit holders onto Aboriginal Land.
- The permit is valid only for the dates specified above in the Consent Areas section.
- This permit is issued subject to the General Conditions contained herein and any Special Conditions and may be amended or revoked either temporarily or permanently if any general condition or special condition is breached by the Permit Holder, or if deemed appropriate by the ALC.
- This permit is issued on the condition that the Permit Holder obeys all directions by Aboriginal owners and any persons delegated the authority by the Anindilyakwa Land Council and may be revoked at any time by the Anindilyakwa Land Council in accordance with the relevant provisions of the ALRA.
- This permit does not entitle the Permit Holder to enter or remain on any Aboriginal sacred site or site of significance and any such entrance on and/or disturbance to a sacred site or site of significance shall constitute a breach of the Northern Territory Aboriginal Sacred Sites Act and the ALRA.
- Firearms must not be carried on to Aboriginal Land without prior written approval from the Anindilyakwa Land Council, and any Permit Holder that is found to carry a firearm on to Aboriginal Land without such approval shall be liable for prosecution under the Firearms Act and their Work Permit will be revoked.
- Liquor is not permitted on Aboriginal Land in the Groote Archipelago. The Permit Holder is responsible for complying with all rules and restrictions made under the Liquor Act (NT) in relation to liquor on Aboriginal Land.
- Whilst on Aboriginal Land, Permit Holders will be held jointly liable for the actions and behaviour of other Permit Holders that they are in the company of without exception.
- All registrable vehicles driven on Aboriginal Land must be registered and driven by a licensed driver at all times.
- This permit does not authorise the cutting of trees or removal of flora from Aboriginal Land, or disturbance to the wildlife, vegetation, waters and soils.
- In the event that this land area needs to be closed due to a death or other cultural reason this permit may be revoked by the Land Council at any time.
